



Poodles to Pit Bulls Clicker Training, Inc. Dog Training Services Contract

- Please give notice to reschedule at least 24 hours before your session. If notice is given less than 24 hours, that session will be forfeit. If inclement weather or other emergency makes for dangerous travel conditions your session will be rescheduled.
- All training packages must be used within 8 months of purchase or they will be considered forfeit.
- There are no refunds, no exceptions.
- Behavior is fluid and dynamic, which means I cannot make any guarantees regarding progress, outcome, or duration of training. In order to get the most out of our time together, you must complete all homework as assigned, practice all management techniques, and follow all protocols. Not doing so will greatly hamper any progress we could achieve.
- All training methods and tools that we will use are humane. It is of utmost importance that you use only the methods I recommend. Doing otherwise will likely confuse your dog and you will not see the progress you would otherwise. With that said, you are always more than welcome to question any method or tool used.
- You understand that attendance at a dog training session may pose some risk to yourself, members of your family, your guests, your dog(s), other animal(s), and property, and expressly assume the risk of any damage or injury (to yourself, your dog(s), and/or any minors attending a dog training session with you) incurred as a result of a dog training session conducted by Poodles to Pit Bulls Clicker Training, Inc. If you choose to bring children to the session, you will be responsible for their care and appropriate supervision.
- To minimize all risks, you agree to disclose to the trainer any danger or sensitivities your dog(s) may present. You will immediately inform the trainer of any situations that may provoke fear or aggression in your dog(s) and be responsible for avoiding those situations. In consideration of your participation in a dog training session or sessions conducted by Poodles to Pit Bulls Clicker Training Inc., you, on behalf of yourself and any minors attending the dog training session(s) with you, waive, release, and agree to hold harmless Poodles to Pit Bulls Clicker Training, Inc. and any and all associated employees, volunteers, agents, insurers, and successors from any and all causes of actions, claims, demands, losses, injuries, and damages of any kind which may be sustained by you, your dog(s), guests, or property in connection with the dog training session. You are responsible for all damages caused by your dog(s), guests, and/or family members.
- Poodles to Pit Bulls Clicker Training, Inc. may, at any time, terminate duties if (a) in the trainer's judgment your dog(s) is(are) dangerous or vicious to the trainer or any other person or animal, or (b) you breach any term or condition of this contract.
- Payment for Assessment Sessions (\$300) and Individual Training Sessions (\$225) is due by the end of the session. Payment for Training Packages (\$880 for 4 sessions or \$1260 for 6 sessions), Day

Training (\$600 for 3 sessions and a transfer, or \$730 for 4 sessions and a transfer, or \$850 for 5 sessions and a transfer), and Puppy Basics (\$640 for 4 sessions or \$930 for 6 sessions) is due by the end of the first session in the package. Payment may be made in person with cash, check, or Venmo. In the event of a cancelled check, there will be a \$20 administration fee, and all future payments must be made either in cash or by Venmo.
